

Terms and Conditions 2019

THE PROMOTER

The promoter is: Softcat plc of Solar House and Lunar House, Fieldhouse Lane, Marlow, Buckinghamshire, United Kingdom SL7 1LW ("Promoter").

THE COMPETITION

The title of the competition is Softcat Carrot Hunt.

Operation of competition: Find the purple carrot hidden in the isometric image. If you find the carrot, enter the coordinates in the form. We will automatically sign you up to our newsletter and you'll be entered into a draw to win a £500 Love2shop voucher. Entering the co-ordinates must be no later than 10am on 23rd April 2019. Promoter will choose one name at random from everyone who has entered the correct coordinates.

HOW TO ENTER

The competition will run from 9:00am on Friday 8th March 2019 (the "Opening Date") to 10am on 23rd April 2019 (the "Closing Date") inclusive. All newsletter registrations must be received by no later than 10am on the Closing Date. All competition entries received after the Closing Date are automatically disqualified. To enter the competition, put in your details and co-ordinates of the carrot in the form. No purchase necessary. The Promoter will not accept: responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or proof of posting or transmission as proof of receipt of entry to the competition. ELIGIBILITY

The Promoter does not accept any responsibility if you are not able to take up the prize.

LIMITATION OF LIABILITY
